

**Memorandum of Understanding (MOU) Between
Wolfpaw Services Inc.
Hereafter referred to as Wolfpaw
and
YEGIX Internet Exchange Community Ltd.
Hereafter referred to as YEGIX**

Covering the period from January 1, 2015 to Dec 31, 2025 and each five-year period thereafter.

YEGIX is an Alberta not-for-profit corporation dedicated to building an open access, maximally neutral, public peering Internet Exchange Point in Edmonton. For this mission to succeed, YEGIX requires the cooperation and assistance of a colocation facility which is maximally network neutral and sees mutual benefit from hosting an Internet Exchange.

Wolfpaw the network-neutral colocation facility which YEGIX has chosen to build an Internet Exchange point.

Wolfpaw recognizes and appreciates the mission of YEGIX, and also sees many opportunities for commercial self-benefit if the creation of this Internet Exchange works according to plan.

Therefore, Wolfpaw agrees to:

1. Provide one half rack of space with power at no charge to YEGIX for the purpose of building the Internet Exchange Point. This rack to contain equipment which serves the purpose of YEGIX. This equipment in whole will be known as the "IX switch".
2. Install at no charge one cable/fibre from the IX switch to any telecom termination point or any other location inside the Wolfpaw facility, for any YEGIX peer with a business relationship with Wolfpaw.
3. Ensure that list prices for cross connection of cable/fibres within the Wolfpaw facility are non-discriminatory, and are made available to the public.
4. Provide a limited number of YEGIX network operators with secure access to the YEGIX equipment in the Wolfpaw facility.
5. Understand that traffic transiting the exchange is covered by the YEGIX peering agreement and all Canadian law.

In accordance with that kind offer, YEGIX agrees to:

1. Use the Wolfpaw supplied resources only for the purpose of building the Internet Exchange Point.
2. Not sublet these resources to provide any additional services such as colocation, VLAN management, off-switch private peering, etc. Those services will remain the business of Wolfpaw, and YEGIX will inform peers that such services must be arranged with Wolfpaw.
3. Understand that all decisions about cabling within the Wolfpaw facility up to the racks will be made by Wolfpaw. YEGIX will bear the cost of all connectivity outside the Wolfpaw facility related to the building of the Internet Exchange Point.

4. Guarantee that the YEGIX network operators will provide necessary personal information required by Wolfpaw for purposes of facility security and will behave in a respectful and confidential manner.

This agreement may be amended at any time with the mutual consent of both parties.
